1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- *The classes of information which we publish or intend to publish;*
- *The manner in which the information will be published; and*
- *Whether the information is available free of charge or on payment.*

The scheme covers information already published and information, which is to be published in the future. All information in our publication scheme is available in paper form.

Some information, which we hold, may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2. Aims and Objectives of the school

The vision of Athelstan Community Primary School is to be an excellent school where children are the top priority. Children will be inspired to learn, develop and grow in a fun, stimulating, exciting yet safe environment. Children and staff will be happy resulting in high standards of behaviour and education.

- To celebrate the successes of everyone in school.
- Help children to improve every year, getting them ready for life.
- Provide opportunities for children to understand how to discover things and solve problems for themselves.
- For all children to show respect towards everyone no matter where they are from, what they believe, what they do or how they look.
- For everyone to have equal opportunities no matter what.
- For everyone to feel safe and to be happy to work with anyone in school knowing that they will be fairly treated.
- To give children a chance to have an active role in the life of the local community.
- For teaching to include a variety of experiences to inspire children's interest and learning.
- For schools and home to work really well together, helping children to be the best that they can be.

This publication scheme is a means of showing how we are pursuing these aims.

3. Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as ‘classes’. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

School Prospectus – information published in the school prospectus.

Governors’ Documents –governing body documents.

Pupils & Curriculum – information about policies that relate to pupils and the school curriculum.

School Policies and other information related to the school - information about policies that relate to the school in general.
